### **Notes:**

A member of the Association in good standing who is entitled to attend, speak and vote at the SGM is also entitled to appoint a proxy to attend, speak and vote in his stead. Such a proxy need not be a member of the Association.

Should a member wish to appoint one of the Association's office bearers to be his/her proxy, the member may simply substitute the position held by his or her intended proxy in place of a proxy's name; for example: insert "Chairman", "Secretary", "Treasurer", etc. That appointed proxy shall be the person who holds the stated position for the duration immediately preceding or during this SGM, even if in an acting or deputy capacity.

The member is not compelled to appoint an alternative proxy (or any office bearer of the Association) to represent him or her at the meeting should his or her first nominated proxy not be present. The member may delete the relevant sections on the form. However, should the member's nominated proxy then not be present, this proxy form will be discarded and of no value.

This proxy form must be completed by the member and submitted by him or her or by an appointed proxy to the secretary before the time of commencement of the meeting. Proxies submitted after the commencement of the meeting will not be recognized.

Proxies may be changed, withdrawn or replaced by the member at any time up to the commencement of the meeting. In this case, a replacement form should be submitted with an instruction to cancel any previous forms.

Should a member who has appointed a proxy or proxies be present in person at the meeting, the member shall then be considered to be representing him or herself. This form of proxy shall be automatically withdrawn and cancelled.

Members who will not be present at the SGM may scan and email the completed, signed proxy form to [secretary@friendsoftherail.com](mailto:secretary@friendsoftherail.com) on or before Friday 27 April 2018.

Proxy forms may also be submitted by post, but given the current unreliability of the postal service, receipt cannot be guaranteed.
